

# SPAIN VISA REQUIREMENT



1. **Passport with validity** of at least three months after return to Pakistan along with its photocopy of all pages bearing visas and stamps.
2. Two photographs (35x45) in white background.
3. **Accreditation of profession.** A letter of presentation by the employer specifying the following:
  - **Period work** at the present organization
  - **Position or post** in the organization
  - **Monthly remuneration/salary**
4. **Travel itinerary**, confirmed **hotel reservations** and flight bookings.
5. **Proof of economic means** with the help of **copies of credit cards (along with bank statement indicating the balance on credit card)** or applicant's **personal bank statements** for the last six months. Bank statements of sponsors will be accepted, if applicable. The bank statements will have to include the address and telephone number of the bank and be signed by two bank officials (**statements are subject to verification**).
6. A **travel health insurance** valid for Schengen States and for the whole duration of the intended stay, with a minimum coverage of 30,000 euro for medical assistance, hospitalization and death repatriation purposes (**original & photocopies**).
7. Copy of national identity card.
8. Copy of B-Form (**if accompanying children**)
9. If you are **visiting family or friends** you will need:
  - Invitation letter **issued by the police station of the sponsor's city of residence.**
  - **Prove of family ties, certified by the Pakistani Ministry of Foreign Affairs (original and copy)**
  - **Letter explaining the purpose of the visit**
10. If you are visiting **due to a medical reason**, you will need:
  - A letter from the Pakistani Hospital treating you indicating that your disease can not be treated properly in Pakistan
  - Appointment letter from Spanish Hospital indicating the estimated cost of treatment
  - All medical documents related to your disease.
11. Applicants who are under 18 years of age must submit a notarized authorization letter from their parents or legal guardians.

## PLEASE NOTE:

- Applicants are strongly advised to apply the visa at least two weeks prior to the date of intended departure.
- Once the visa form is filled up and signed, a one photocopy will have to be made and submitted with one photograph pasted (not stapled) on each of the two forms.
- The Embassy reserves the right to ask for any additional document apart from those mentioned above that it deems necessary for the issuance of visa and call for an interview.
- Compliance with the above-mentioned conditions does not automatically guarantee the issuance of the visa. After the issuance of the visa, the competent authorities may refuse entry into Spain upon arrival. In such case, the Spanish government accepts no liability.
- The application will be refused if the Embassy detects any fake document.
- Visa applications must be submitted along with one set of original documents. Only those documents that have to be returned to the applicant should be accompanied by a photocopy.
